



## INFRASTRUCTURE

### Internet/Phone Connectivity

CenturyLink.....96 strands in each high speed fiber optic line, 1.5MB DSL presently, 25MB DSL in the near future, up to 1,000 dedicated internet access connections, Layer 2 Ethernet, Adtran, ShoreTel, Cisco, and Avaya phone system available.

### Power

Cheney Light Department.....10-12 Megawatts as of 2012, Scheduled to upgrade to 15-20 Megawatts of service mid-summer 2013.

### Natural Gas

Avista Utilities.....2” PE mains with 3/4” service lines to each parcel. Main will be upgraded to a larger diameter when demand calls for it.

### Water

Cheney Water Department.....8” lines service each parcel, leading to a 12” main line under Fred Johns Way. Fire hydrants have been installed and have access to the City’s five water reservoirs totaling 4.2 million gallons.

### Sewer

Cheney Wastewater Department.....6” lines service each parcel, leading to an 8” main line under Fred Johns Way.
